## How the Mobile Enrollment Experience Works

When an employee becomes eligible to enroll in your company's plan, if they are not already using the ADP Mobile App for another ADP service, they can download the ADP Mobile App from the App Store. Either way, once they have the app, they will automatically see the Retirement Dashboard display with an "Enroll Now" option. To start the enrollment process, all they need to do is click on the "Enroll Now" button. If the employee has notifications enabled on their ADP Mobile App, they will also receive enrollment reminders.

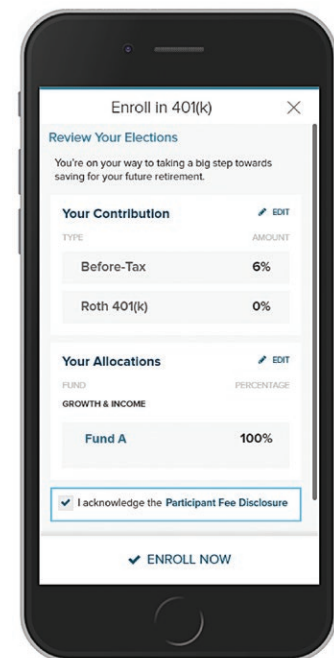
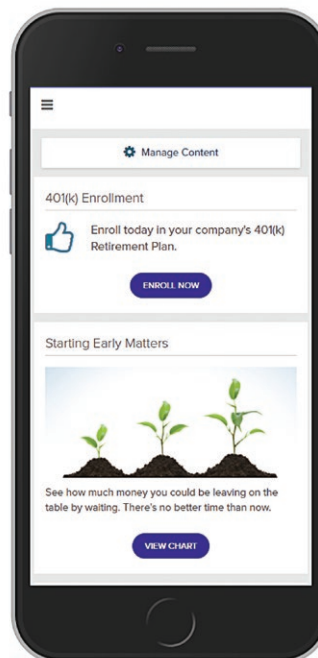
